### Upcoming ANHIX Events

The Summer Symposium/Golf Tournament will be held on **Wednesday, September 11, 2019** at the Ranch Golf and Country Club at Acheson.

The ANHIX-Digital Health Canada Conference is in the early planning stages and is tentively scheduled for **February 2020** in Calgary. More information will be published as it becomes available.

The ANHIX Spring Symposium and AGM was held at the Holiday Inn Conference Centre South on May 8, 2019.

The opening speaker was Anthony Kaul, co-founder and COO of Cloud DX whose topic was new innovations in digital health.

He began by describing barriers to innovation in healthcare including:

- Cost of failure high so risk aversion is high;
- Complex workloads enhance risk of change; and
- Misalignment of benefits and costs.

To succeed, innovation must:

1. Substantially improve outcomes;
2. Reduce clinician workload; and
3. Cost considerably less than current solution.

He then worked through an example of a remote vital signs monitoring

program to treat COPD exacerbations. He went on to speak to the importance of choosing wisely what to work on and assessing the drivers. He finished by describing examples of innovation today and where we might go in the future.

The next presenter was Tim Murphy, Vice President, Health, Alberta Innovates. Tim described Alberta Innovates' role – "To create economic value AND improve patient outcomes by integrating emerging technologies into healthcare in Alberta in a sustainable manner" – and the steps they were taking to position Alberta for the digital health future. He also described the two top challenges they faced; a less than optimized ecosystem, and a shortfall in data and business readiness.

Rob Novotny, VP, Client Engagement and Strategy and Tyson Roffey, Assoc. Partner Healthcare, IBM Global Services then spoke to "Driving Accountable Care through Analytics".

The problem they were confronting was using data to drive accountable care and then implementing training to support change. They went on to describe a high impact framework that included dimensions, use cases, impact evaluation and focus determination. They then posed some generic questions which they encouraged the audience to respond to before taking the audience through an interactive workshop.

After lunch, Mike Burgoyne, National Healthcare Lead, Ricoh, discussed "Digital Strategies for Improved Care Collaboration". He began by describing care collaboration and how it was a key outcome of many digital health initiatives. He described the problem where patient care is often delayed while clinicians wait for information and as much as \$12 billion annually is wasted as a result of communication inefficiencies. He then described three strategies for digital collaboration; point of care capture, paperless procedural consents and visual communication tools.

He described examples that support the three strategies before taking the audience through a case study at a Canadian Maternity and Children's Hospital.

The last speaker of the day was Rhonda Collins, Chief Nursing Officer, Vocera Communications, who spoke to solving the communication challenge.

She talked about the adoption of technology in healthcare and the barriers to adoption of mobile technology. She then spoke in detail of a study to determine nurse's perceived usefulness of secure texting for the purpose of patient care. She outlined the study's purpose, the clinical considerations, the study design, its framework, how the results were measured, suggestions for future research and project conclusions.
